24/15 Chairman's Announcement

In the interests of openness and transparency, councillors and members of the public are reminded that the law permits any person to film, record, photograph or use social media in order to report on the proceedings of a meeting of the Parish Council or its committees when they are open to the public. This does not extend to live verbal commentary.

Filming and photography will only be permitted from the area designated. No flash photography or additional lighting should be used without prior consent.

Anyone wishing to report on the meeting should notify the Clerk or Chairman so that they can be afforded reasonable facilities. People under the age of 18 or other members of the public not wishing to be filmed or photographed should notify the Clerk or Chairman and should sit in the area designated for this purpose.

25/15 Apologies

Apologies were received and accepted from Cllrs Rosa Blunt and Pat Wiseman.

26/15 To receive an overview of the Dong Energy Race Bank Wind Farm project from 7pm to 7.30pm

Brochures were handed out to the meeting and it was explained that Dong Energy have been building off-shore wind farms since the 1990s and took over the Race Bank project from Centrica in 2013. There will be 580 megawatts of power and 91 wind turbines. Implementation for the onshore substation starts on 19 February 2015 with Murphy's. In April/May there will be work to the onshore cable route. Newsletters will be distributed to the community to keep the residents informed and a liaison office will be appointed, contact details will be given in the next newsletter. Dong are currently looking at horizontal operational drilling to minimise impact but this is not part of the current planning consent and will have to be subject to a planning application. Concerns were raised about piping under the sea defences. Dong are considering it in engineering terms and will clearly indicate their solutions. Flood Risk assessments have been carried out. There was a discussion about drilling and piping. Dong are still evaluating which method will be the most suitable. Discussion regarding the water for cooling the drill - preference to extract from the Nene, traffic management is being considered if vehicles have to be used for water transportation. The onshore substation is sited next to the National Grid Sub Station. This Sub Station is particular for Race Bank Wind Farm. Each wind farm has to have its own infrastructure, no sharing of cables. Companies cannot own the generating equipment as well as the transmission assets. Dong will continue to own the Wind Farm but the substation will be sold to another party once completed. Councillors asked if Dong have any community assistance funds. Dong Energy will engage positively with the community but there is no formal community fund. Cllr Richard Blunt asked for the Liaison Officer to attend a parish council meeting every 6 months to keep parish council updated.

L Newman commented that 'Countryfile' (BBC) had reported that there is 15% renewable energy but it costs £1million to turn off the turbines periodically and this does not make sense. P Ford – Dong, advised that Dong is working hard to reach renewable targets.

L Newman – will there be jobs for local people? P Ford – Dong, there will be some jobs but Murphy's are the contractor and they will use local subcontractors. The employees will be spending their money locally too.

Cllr Richard Blunt thanked the representatives from Counter Context, Dong and Murphy's for attending

Cllr Richard Blunt advised that Walpole Cross Keys Parish Council were also in the process of carry out an Neighbourhood Plan and there was a great deal of work involved, it is a similar consultation process to the LDF and if approved it will supersede the LDF.

Cllr Richard Blunt remarked that the idea is good. There was a general discussion regarding the Crier and Website. There are still issues of the Crier not being delivered in some areas. Cllr Patrick will look into this.
