Cllr Blunt advised that the hearing for The Walpoles will be on 18th November a 2pm. Clerk will contact Mary Ralph at Brown & Co to arrange a preparation meeting. The Borough Council has made an informal response to the Inspector, which is available on the BC website. Also, due to a land bank shortage, failed planning applications are being resubmitted to the Planning Authority for planning consideration.

The Pinnacle Carving has suffered some weather and age related damage which has only been brought to light since cleaning. Fairhaven Stone have offered some solutions and advice regarding the existing lettering. The Parish Council agreed for the clerk to contact War Memorials Trust regarding the options, most favoured was to carry out the lettering work as advised and replace the Pinnacle. Clerk will report to War Memorials Trust.
